1. 'Transmission System for Phase-I Generation Projects in Orissa-Part-C' at an estimated cost of ₹ 2569.25 Crore, with commissioning schedule of 36 months from the date of investment approval.
2. 'Transmission System for transfer of power from Generation Projects in Sikkim to NR/WR – Part-B' at an estimated cost of ₹ 1585.12 Crore, with commissioning schedule of 32 months from the date of investment approval.
3. 'Establishment of National Transmission Asset Management Centre (NTAMC)' at an estimated cost of ₹ 195.39 Crore, with commissioning schedule of 36 months from the date of investment approval.
