The Board of Directors of the Company in its meeting held on **13.05.2014** has appointed me as a Scrutinizer for conducting the postal ballot voting process.

The Company has completed the dispatch of postal ballot notice & form through electronic mail on 14.06.2014 and dispatched the same in physical mode along with postage prepaid business reply envelope on 16.06.2014 to its members whose name(s) appeared on the Register of members / list of beneficiaries including by e-mail to all those members who had registered their e-mail ids with the company.
2. Particulars of all postal ballot forms received from the Members including electronic votes (as reported by KARVY, agency facilitating e-voting platform) have been entered in a register separately maintained for the purpose.
3. The postal ballot forms were kept under my safe custody in sealed and tamper proof ballot boxes before commencing the scrutiny of such postal ballot forms.
