Sub: **Investments approved by Board of Directors of POWERGRID**

In terms of clause 36 of the Listing Agreement, the following is intimated:

The Board of Directors of POWERGRID during their meeting on 02.08.2011 approved the following four investment approvals for:

1. 'Transmission System for connectivity of MB Power (M.P.) Limited' at an estimated cost of ₹ 425.51 Crore, with commissioning schedule of 25.5 months from the date of investment approval.
2. 'Common System associated with ISGS Projects in Krishnapatnam area of Andhra Pradesh' at an estimated cost of ₹ 1637.34 Crore, with commissioning schedule of 36 months from the date of investment approval.
3. 'Provision of Spare ICTs and Reactors for Eastern, Northern, Southern and Western Regions' with commissioning schedule of 16 months from the date of investment approval, at following cost estimates:
 - (a) Spare Transformers in Northern Region - ₹ 38.43 Crore,
 - (b) Spare Transformers & Reactor in Eastern Region - ₹ 77.77 Crore,
 - (c) Spare Transformer & Reactor in Southern Region - ₹ 18.90 Crore, and
 - (d) Spare Transformers & Reactors in Western Region - ₹ 64.09 Crore.
4. 'Integration of Pooling Stations in Chhattisgarh with Central part of WR for IPP Generation Projects in Chhattisgarh' at an estimated cost of ₹1391.97 Crore, with commissioning schedule of 28 months from the date of investment approval.
